# The Administration's Response to the Questions Raised at the Meeting of the Legislative Council Panel on Public Service Held on 21 January 2008 on the Retention and Recruitment Situations of Civil Service Grades Selected for Non-Directorate Civilian Grade Structure Reviews

At the Panel meeting held on 21 January 2008, the Administration updated Members on its recent invitation to the Standing Commission on Civil Service Salaries and Conditions of Service for conducting grade structure reviews for selected non-directorate civilian grades, and provided a verbal account of the retention and recruitment situations of these grades. This note sets out the retention and recruitment statistics for the non-directorate ranks of Veterinary Officer grade, the Government Counsel grade, the Legal Aid Counsel Grade and the Solicitor grade.

#### Retention Statistics
